


President's report

**I. Public awareness:
WSV webpage
sustainability and use
in coordination with
social media**

1. Transition towards a sustainable webpage helping the objectives of the WSV: Due to the lack of budget by the WSV, with its own research funds, the Presidency decided to support the migration of contents and maintenance of the webpage since the end of 2024 and the whole 2025. In relation to the social networks, exchange of information with the Communications Committee Chair, Faride Peña, and Michael O'Connell was required for further cooperation in this field.
2. Ensuring the payment of new members and renewals. With the help of Michael O'Connell and our Treasurer, Peter Schafer, the Chair of the Membership Committee, Bhanu Prakash Nunna, with hard work, clarified the updated list of members and their contact, respecting all privacy requirements. This work included, with the generous help of Pamela Kerschke (WSV member and volunteer for this) facilitating paypal and card payment in relation to the German bank with the WSV account.

II. Support to practice

3. Working on or supporting practice guides on the principles of justice/rights/treatment of victims and have them in **open access in various languages**. **This is to be developed in the future**, although collaboration has started with several organisations and also victimology groups working in scientific societies.
4. Always in collaboration, designing and sharing training for practitioners/researchers/policy makers/activists. It has been debated in EC online meetings the possibility of offering online courses, also to get some financing for the WSV activities. **This should be developed in the future**.

III. Policy making

5. Diverse territorial scales: international, national and local regulations, programmes, strategies, actions in all continents. Contacts with Victim Support Europe and other international organisations and scientific groups and societies have been developed when required by them (e.g.: Victimology group of the European Society of Criminology). Also in other regions of the world when invited to conferences with practitioners and policy-makers.
6. Using a broad notion of victimisation in relation to justice, public health, peace, safety, security, welfare and economy, public services... This notion has been adopted in all activities to amplify the impact of the WSV with different stakeholders along the diversity of countries and victimisation processes in relation to all interventions and contributions.

IV. Debate/networking

7.Attending and organising online and life events (always with the horizon of the next ISV -announcing it, also in the signature of emails-) to share with different stakeholders, grassroot organisations and the public. The President has been invited to online and face-to-face conferences in Asia, Africa, Europe, North America and Latin America. If in person, all travel expenses have been personally paid with her own funds.

There has been particular collaboration for the celebration of the 40th anniversary of the 1985 UN Declaration on victims with the help of the UN Liason Committe Chair, Dawn Beichner.

Particular collaboration has been developed for the organisation of the next ISV with the kind invitation of Jo-Anne Wemmers to Montreal.

Other basic objectives in collaboration with the SG and the kind help of other EC members

- Clarification of the guiding regulations of the WSV in force.
- Notary requirements by the treasurer in relation to the non-profit status of the WSV.
- Drafting the agenda, organising online meetings and recording for the minutes of the EC.

Gratitude and recommendations

With deep gratitude for the work done this first year of mandate, EC members should collaborate further with basic tasks and also organising activities for all members at large beyond the 3-year Symposia. The creation of sections, following the Iberoamerican initiative, and always with respect of the WSV basic standards and procedures, can help in this task.

Priorities: Resources and outputs

- We need to raise resources for the WSV and make the WSV membership worth it by providing more participation of members in the Committees and in the WSV activities the whole year.
- Renew the alliance with the Dubrovnik course.
